1.0 Introduction

- 1.1 The purpose of this report is to meet Ark's obligations under the Procurement Reform (Scotland) Act 2014 ("the Act"), Section 18(1) to prepare and publish an annual procurement report on its regulated procurement activities, covering the period 1 April 2024 to 31 March 2025.
- 1.2 In May 2023 Ark's 2023-26 Procurement Strategy was approved by Ark's Board of Management. This document sets out a clear and structured approach to all of Ark's procurement activities, outlining what will be done to deliver quality, price, experience, specialist knowledge, and value for money, in order to achieve best value, for our customers and stakeholders.
- 1.3 The Procurement Strategy's four overarching themes are:
 - Consistently apply good procurement practice across the organisation;
 - Effectively plan, monitor, and review current / future procurement activities;
 - Tender and award contracts in accordance with Ark's Financial Regulations, legislative requirements, and best practice;
 - Encourage suppliers to work in a socially responsible manner.
- 1.4 The scope of the strategy covers all functions and services across Ark.

2.0 Summary of Regulated and Unregulated Procurements

2.1 Over the course of the period covered by this report the following regulated and non-regulated procurement exercises have been undertaken:

- 2.2 Regulated procurement is completed when the award notice is published or where the procurement process otherwise comes to an end. A more detailed breakdown of this activity is noted at Appendix 1.
- 2.3 In undertaking its regulated procurements, every care has been taken to ensure that Ark awards its contracts to suppliers who are capable, reliable and who can demonstrate that they meet high ethical standards and values in the conduct of their business.

3.0 Community Benefits

- 3.1 The Public Contracts (Scotland) Regulations state that for every procurement over £4m, Ark must consider how we can improve the economic, social, or environmental wellbeing of the local area through inclusion of community benefit clauses. This is to assist with achieving sustainability in contracts activity, including targeted recruitment and training, small business and social enterprise development, and community engagement. Where possible, relevant and proportionate, and where they are considered not to have a negative impact on the delivery of value for money, such clauses may also be included in regulated procurements valued at below £4m.
- 3.2 Ark's approach to identifying community benefits is carried out on an individual project basis through engagement and consultation with stakeholders. As part of the tendering process, tenderers will be asked to describe their approach to delivery of community benefits noted within the tender specification.
- 3.3 Ark is committed to applying Community Benefits, where relevant and proportionate to do so.

4.0 Supported Business

- 4.1 Regulation 21 of the Public Contracts (Scotland) Regulations 2015 allows public bodies the ability to reserve public contracts for supported businesses. Supported businesses provide essential job opportunities for disabled and disadvantaged people within our communities, enabling such employees to become more independent, while also delivering a range of excellent supplies and services.
- 4.2 Ark does not have any contracts which are currently delivered through a supported business, and no contracts were awarded to supported businesses during this period.
- 4.3 In future periods, Ark is committed to seek out opportunity to award contracts to supported businesses where this is possible to do so, and Framework Agreements will be actively explored.

5.0 Future Regulated Procurements

5.1 Section 18(2)(f) of the Act states it is mandatory that an annual procurement report must include "a summary of the regulated procurements the authority expects to commence in the next two financial years". Ark has 10 regulated procurements due for renewal (or subject to contract extension) over the next two

financial years. Details of these anticipated contract requirements are shown in Appendix 2.

5.2 As part of Ark's annual programme of internal audit review, we anticipate Procurement activity to be within scope in 2026/27.
